RULES AND REGULATIONS

**Disclosure: We at Earthday Campground, Inc. DO NOT condone or allow riders to enter or drive on PA State or Township roads without a legally licensed vehicle approved by Penn Dot.**

**This is a Campground Not an ATV/Riding Park! All off road, non-licensed vehicles Must Be Trailered At All Times In the Campground!**

1. Riding of motorized vehicles of any kind is only allowed at speeds not to exceed 5 miles per hour. This speed limit will be strictly enforced. Riding is only permitted on designated roadways. Motorized vehicles are not allowed on nature trails, hollows or wooded area.
2. Access to AOAA and Reading Anthracite Company property is not currently available from Earthday Campground.
3. Only 1 RV or Tent is allowed per campsite. Campsites (RV or Tent) allow for a maximum of 6 persons per site and 2 vehicles per site. Maximum occupancy for cabins will be regulated by sleep guide ratings.
4. All vehicles, RV's and trailers must be parked on your campsite or designated parking areas.
5. Camping permit holders are responsible for the action of all camping party members and visitors.
6. We encourage a "quiet campground atmosphere". Loud partying, rowdy behavior, loud generators, racing engines and other disruptive behavior will not be tolerated. Fireworks and discharging of firearms is prohibited. Quiet Hours 10:00 PM to 7:00 AM will apply.
7. All campers, their guests and vehicles must be registered at the campground office. Guest must leave the premises by 10:00 PM.
8. No Hunting is allowed on the campground.
9. Consumption of alcohol is restricted to registered campsites only.
10. Pets must be kept on a leash. Please clean up after your pet.
11. Campfires are restricted to designated areas and not allowed during dry periods. All fires must be extinguished before campers leave the area. **Please use the firewood provided for you. Do not bring firewood with you.**
12. Keep your campsite area clean of all trash and debris. Please bag all garbage and deposit in dumpster provided. Break up boxes before placing into dumpster. Only camping garbage is allowed.
13. Our insurance company prohibits any chain-saw activity on the premises. Do not cut, carve, chop or damage any live trees.
14. Earthday Campground Inc. will determine the boundary lines of each campsite. Encroachment on neighboring sites, roadway, paths or other area will not be permitted. Barrels, boxes fencing or other objects are not to be utilized as property lines indicators. All property line disputes should be presented to management. Debris or

clutter of any kind is not allowed on the premises. Make shift huts, shelters, garage type structure are not allowed. Please keep all sites clean and neat.

15. Rental Houses & Rental Campers: Futons, couches and mattresses with bed frames are provided, however you must bring along your own bedding (i.e. sleeping bag, pillow, sheets, blankets, etc.) and towels.
16. All seasonal sites must be paid in full by April 1<sup>st</sup> of each season. Seasonal Campers are responsible to maintain their sites including cutting, trimming and cleaning.
17. This is a seasonal campground. From December 1<sup>st</sup> to April 1<sup>st</sup> there will be no road maintenance. All campers, vehicles, personal property and other possessions must be fully insured by individual campers. Proof of insurance must be on record at Earthday Campground Inc.
18. All guests at Earthday Campground Inc. who stay at any site or use any of the facilities do so at their own risk. Earthday Campgrounds Inc. is not responsible for injuries or damage of any sort for any reason. All guests of Earthday Campground Inc. agree to release Earthday Campground Inc. and its affiliates, officers and family member, volunteers, fellow campers and employees of all liabilities for the loss or damages to property and injury to his/her person arising out of his/her use of Earthday Campground Inc. facilities and agrees to indemnify and hold harmless Earthday Campground Inc. its officers, family members, volunteers, fellow guests and employees against any and all claims of any type.
19. We retain the right to evict without prior notice anyone who in our opinion is creating a disturbance or being a nuisance.
